WHEREAS, the City Commission desires to give recognition to the contributions and public service made by Rev. James A. Latham by adding the name "Rev. James A. Latham Street" to a portion of Northwest 9<sup>th</sup> Street; now, therefore,

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:**

**SECTION 1.** That the designation of a portion of Northwest 9<sup>th</sup> Street lying between North Powerline Road (SR 845) and Northwest 18<sup>th</sup> Avenue shall have the dual designation of Northwest 9<sup>th</sup> Street and "Rev. James A. Latham Street" with Northwest 9<sup>th</sup> Street to be displayed most prominently on the uppermost portion of appropriate signage.

**SECTION 2.** That the City Clerk is directed to forward a copy of this Resolution to Broward County, so that the County may prepare and install the appropriate signage.

**SECTION 3.** This Resolution shall become effective upon passage.
