





Dear Ms. Barszewski,

I am writing to request a letter of no objection regarding an amendment to a portion of the non-vehicular access line (NVAL), adjacent to Atlantic Boulevard, located on the Residences of Palm-Aire plat which was recorded in Plat Book 181, Page 178. As you may be aware, the plat was recorded on June 25, 2015. I represent FCI Development Ten, LLC which is the owner of a portion of Parcel B located within the Residences of Palm-Aire plat. This portion of Parcel B, also referred to as the Atlantico project, received site plan approval on August 26, 2015 which was subsequent to the plat's recordation.

During the site planning approval process, the City of Pompano Beach Fire Department requested that the Atlantico project provide for an emergency access point along Atlantic Boulevard. When this request was made, our civil engineer sought the approval of the Florida Department of Transportation (FDOT) to create an access point off of Atlantic Boulevard for emergency access purposes only. This opening along Atlantic Boulevard would not traditionally be granted in this location, but since the opening is for emergency access, the FDOT was willing to grant the opening.

At this time, we are now required to amend the portion of the NVAL through Broward County per the Development Order issued by the City of Pompano Beach (Planning and Zoning No. 12-12000013). The first step in the County's process is to obtain a letter of no objection from the City of Pompano Beach. I respectfully ask that the City of Pompano Beach provide the necessary letter of no objection so that we may proceed with the amendment of the NVAL through Broward County. Attached to this letter, I have highlighted the portion of the NVAL (on the plat) and included a copy of the approved site plan depicting the proposed amendment and copy of the boundary survey for Atlantico. I have also attached a copy of the City of Pompano Beach's Development Order stating the requirement to seek an amendment of the NVAL in the specified location. Also included with this letter is a check in the amount of \$350.00 for the NVAL application fee. Upon review, if you should have any questions, please feel free to contact me or Tara Patton, AICP, the planner working with me on this project. Thank you for your time and consideration.
