Summary of Purpose and Why:

Staff is seeking City Commission approval of a Resolution to execute Work Authorization No. 1 with The Whiting-Turner Contracting Company ("W-T") in the sum of \$96,900.00. W-T will assist the City by evaluating proposed plans for constructability and preparation of a Guaranteed Maximum Price ("GMP"). W-T will attend meetings with the City's design team, prepare a project schedule, provide an opinion of costs, and coordinate efforts by surveyors, environmental and geotechnical professionals as needed. Staff recommends approval.

Issue

Staff is seeking City Commission approval of a Resolution to execute Work Authorization #1 with The Whiting-Turner Contracting Company ("W-T") to provide Pre-Construction services to reconstruct the City's Fishing Pier (See Location Map) in accordance with RFQ L-15-16 (See Exhibit "A"), in the amount of \$96,900.00 (See Exhibit "B").

Recommendation

Staff recommends Approval.

Background

On January 15, 2016, the City published RFQ L-15-16 seeking qualified firms to provide Marine Construction services. The City received pre-qualification packages on February 16, 2016, and a panel of reviewers ranked W-T No. 1.

The pier was built in the early 1960s with a typical life span of +/- 50 years. The pier is approximately 865' long and 18' wide (+/- 16,000 Sq. Ft.). A Volkert & Associates report (2005), and subsequent Lakdas-Yohalem structural analysis (2013) indicated the need to replace the pier having reached the end of the pier's structural life span.

The City retained Bridge Design, Inc. to provide design services. The initial design considerations include re-building the pier at or above the 100-year storm event elevation (17.4' NGVD or 17.4' above sea level) (current pier is at 16.5' NGVD good for 20-year event) and increasing the pier width to 30 feet to improve functionality and use (fishermen occupy 5' in width with their rods). Staff had identified widening the pier would provide

more room for fishermen, pedestrians, and vendor carts (if allowed). In addition, Staff believes constructing cantilevered sections (balconies) would further widen and beautify pier (with umbrellas/awnings). Other design considerations include permanent sea-turtle friendly lighting fixtures; sea-turtle compliant lighting along the railings; adding educational signage (Sea-Turtle, Marine Wildlife); creating a connection to Pompano Beach Boulevard Streetscape and the Pier Parking Lot/Garage; installing supplemental power sources for special events; adding supplemental water sources for special events and/or maintenance needs; and, installing handicap railings to comply with ADA standards.

To ensure the project can be constructed as desired and within budget, Staff has asked W-T to provide a proposal to conduct pre-construction services for the Fishing Pier Improvements Project. Under said proposal W-T would provide the following services:

- Attend Pre-Construction Meetings
- Assist with project scheduling
- Provide Cost Estimating Services:
 - Initial Opinion of Probable Costs
 - Constructability Review
 - Generate Guaranteed Maximum Price (GMP)

W-T has the necessary credentials to provide Construction Management Risk services. Recently, the firm provide similar services for another City/CRA project (Downtown Pompano Streetscape Improvements Project, MLK Boulevard from Dixie Highway to NW 6 Avenue). The firm's performance was above average and exceeded Staff's expectations. Moreover, the firm has plenty of experience with similar marine related projects. For example, W-T was responsible for the City of West Palm Beach's Common Docks (\$10 million), Baltimore Inner Harbor (+/- \$20 million), Chesapeake Bay Bridge (\$180 million), and multiple projects for the U. S. Navy.

Staff recommends awarding W-T a Pre-Construction Services Work Authorization No. 1 in the sum of \$96,900.00. Any sums not used during pre-construction will be credited back to the City.

**CONSTRUCTION MANAGEMENT AT RISK CONTRACT SERVICES FOR
CITY OF POMPANO BEACH FISHING PIER**

Pursuant to a contract between The Whiting-Turner Contracting Company (“CM”) and the City of Pompano Beach dated _____ (Resolution _____), this Work Authorization No. 1, when executed, shall authorize CM to perform Construction Management at Risk services as requested by the City.

I. PROJECT DESCRIPTION

It is the City of Pompano Beach’s intention to conduct pre-construction activities for the Pompano Beach Fishing Pier Project. More specifically, it is the City’s desire to conduct a pre-construction analysis in accordance with CM’s proposal (See Exhibit “B”).

It is the CITY’s desire to award CM a Work Authorization in the sum of \$ 96,900.00 (including contingency) to provide pre-construction management services for this Marine Construction Improvement project.

II. SCOPE OF WORK

The scope of work identifies the level of effort that shall be performed by CM in assisting the CITY with construction services. The services to be provided by Contractor to the CITY under this task order shall consist of the following tasks:

TASK 1 – CM shall perform the following work in support of the project:

Pre-Construction Progress Meetings - \$7,400.00

The scope shall include regularly scheduled team progress meetings attended by CM, as well as the design team, City representatives and others. CM will create agendas and produce meeting notes from each meeting documenting the issues of the project, assigning responsibility for issue resolution and tracking the timelines for issue resolution.

TASK 2 – CM shall perform the following work in support of the project:

Scheduling - \$8,500.00

Based on the best available information, CM will develop a master Pre-Construction and Construction Phase bar chart schedule incorporating design development, permitting, plan review, guaranteed maximum price preparation, submittal review and approval, long lead



item identification and procurement. Design team will identify and/or provide required permits. The Pre-Construction schedule will include summary activities for construction of the key project elements. This activity includes consultation with an outside scheduling consultant. The schedule will be presented to the City for review and comment as necessary until established, and shall be updated monthly thereafter to track preconstruction progress and for inclusion in the GMP.

TASK 3 – CM shall perform the following work in support of the project:

Cost Estimating

INITIAL OPINION OF PROBABLE COST - \$8,500.00

CM's budget will be based on the best available current information, and it is intended to provide the City with initial input on the conceptual cost of the work. This budget will also provide conceptual feedback related to the various options or alternates that the City Beach and the design team may be considering for the fishing pier, in order to assist with the decision making process. This budget may rely both upon CM's in-house takeoff utilizing historical unit prices from similar projects, as well as subcontractor and vendor feedback. Work shall entail review of the plans provided, quantity surveys, review with the City and design team to discuss final design intent, and potential construction scope gaps.

CONSTRUCTABILITY REVIEW - \$14,400.00

The scope will require continual review of the plan details as periodically provided by the Design Team. The review will identify design criteria which may present considerable constructability challenges, and also will assist the Design Team in any plan modifications and re-design.

GUARANTEED MAXIMUM PRICE (GMP) - \$41,100.00

The scope consists of CM preparing the GMP based on substantially complete construction documents provided by the design team. Final GMP shall be provided at 100% plans or upon securing all required construction permits. The GMP will include a detailed line item budget for all major items of work to be performed. Those project scope of work items that the plans are not yet developed for, may be included in the GMP as Allowance items, or may be added to the contract at a future date by change order. CM's general conditions shall be detailed as well as the construction phase fee. The GMP shall also include Contingency funds per City's direction. The aforementioned information shall be presented to the City along with all supporting documentation for review and approval. This agreed upon document shall become the basis of the construction services phase of the project and shall conclude the pre-construction services phase of the project. CM shall attempt to secure no less than three (3) proposals for services for each discipline, backup that shall be submitted to the City for review. If CM is unable to secure at least three (3) proposals, then CM shall provide backup demonstrating the CM's outreach plan to subs. CM shall be allowed to use own personnel for specific tasks.



TASK 4 – CM shall perform the following work in support of the project:

Contingency - \$17,000.00

This task will allow for input from third party consultants as needed including, but not limited to, surveyors, environmental and geotechnical professionals.

III. PROJECT SCHEDULE

All Tasks: Approximately Three (3) months.*

*Note: schedule is subject to plan and permitting review by outside government agencies and may be extended.

IV. COMPENSATION

Fees for professional services rendered in connection with this authorization shall be a lump sum basis. The Fee established for this Work Authorization is as follows:

SECTION II INTRODUCTION

1. General

The City of Pompano Beach Public Works Department (CITY) has identified major projects and programs within the CITY boundaries with the goal to make the City more attractive to residents, visitors and tourists and promote economic growth and activity as detailed in the City's Strategic Plan.

The intent of this Request for Qualifications (RFQ) is to select the most qualified firm based on selection committee recommendations and City Commission approved ranking, with whom to negotiate a Guaranteed Maximum Price (GMP) Agreement and enter into a Construction Manager at Risk (CMAR) Contract to carry out Construction Manager at Risk (CMAR) duties to construct a new Fishing Pier.

The CITY, as part of the City's Capital Improvement Program and Strategic Plan, are providing for the renovation and replacement of existing facilities and the construction of new facilities within the City. The proposed improvements include, but are not restricted to, structural replacement of an existing +/-1000 LF fishing pier, addition of pedestrian lighting, educational placards and signage, shade structures, conversion of existing overhead utilities (e.g. electric, telephone and cable TV) to underground distribution, installation of new drainage, replacement of water and sewer distribution lines, and streetscape improvements, including lighting, sidewalks, pavement and landscaping, and other improvements outlined in the final construction plans. The proposed improvements may not occur at the same time, but may be phased as necessary.

Construction drawings and specifications for the project will be provided by the City to the awarded firm to develop a GMP and Construction Manager at Risk contract accordingly, on an as needed basis as determined by the City.

2. Eligibility

Due to the requirement that the Contractor need to be readily available for meetings, discussions and tours within the areas of responsibility, it will be necessary for any proposers to have an office physically located within the tri-county areas of Miami-Dade, Broward, and Palm Beach County. This office must be an active facility from which consultant services are routinely provided and not merely a post office box or other type of mail drop, nor can it be the office of simply a representative agent. The CITY reserves the right to inspect any facility designated by the proposer to insure that it complies with this section.

3. Small Business Enterprise Program

The Pompano Beach City Commission has established a voluntary Small Business Enterprise (SBE) Program to encourage and foster the participation of Small Business Enterprises in the central procurement activities of the City. The City of Pompano Beach is strongly committed to ensuring the participation of Small Business Enterprises (SBE's) as contractors and subcontractors for the procurement of goods and services. The definition of a SBE, for the purpose of the City's voluntary program, is taken from the State of Florida Statute 288.703(1).

As of the date of publication of this solicitation, a small business means an independently owned and operated business concern that employs 200 or fewer permanent full-time employees and

that, together with its affiliates, has a net worth of not more than \$5 million or any firm based in Florida that has a Small Business Administration 8(a) certification. As applicable to sole proprietorships, the \$5 million net worth requirement shall include both personal and business investments.

The City encourages all firms to undertake good faith efforts to identify appropriate Small Business Enterprise partners, particularly Pompano Beach-based firms. Sources of information on certified Small Business Enterprises include the Broward County Small Business Development Division, the State of Florida Office of Supplier Diversity, South Florida Water Management District, and other agencies throughout the State. The City includes links to these organizations from the City's website www.pompanobeachfl.gov.

The City has set a 15% voluntary Small Business Enterprise Goal for this project. SBE Forms are located at the end of this solicitation, and all firms responding must return a response of participation or non-participation in order to be considered responsive for evaluation purposes.

Please indicate in your response if your firm is a certified Small Business Enterprise, and include the completed "Good Faith Effort Report" form with your proposal. Proposers should submit Exhibit A, detailing the list of SBE firms to be used on the proposed contract, and a completed Letter of Intent, Exhibit B, for all participating SBE firms. Submit Exhibit C listing SBE firms that were solicited but not selected. Submit Exhibit D explaining your firm's good faith efforts to include SBE firms on this contract.

4. Local Business Program

On March 23, 2010, the City Commission approved a Resolution establishing a Local Business Program, a policy to increase the participation of City of Pompano Beach businesses in the City's procurement process.

You can view the list of City businesses that have a current Business Tax Receipt on the City's website, and locate local firms that are available to perform the work required by the specifications. The business information, sorted by business use classification, is posted on the webpage for the Business Tax Receipt Division: http://pompanobeachfl.gov/index.php/pages/dev_scv_btr/btr.

The City has set a 15% voluntary Local Business goal for this project. Local Business program forms are located at the end of this solicitation, and all firms responding must return a response of participation or non-participation in order to be considered responsive for evaluation purposes.

The City of Pompano Beach is strongly committed to insuring the participation of City of Pompano Beach Businesses as contractors and subcontractors for the procurement of goods and services. Proposers are encouraged to participate in the City of Pompano Beach's voluntary Local Business Program by including, as part of their package, the Local Business Participation Form (Exhibit E,) listing the local businesses that will be used on the contract, and the Letter of Intent Form (Exhibit F) from each local business that will participate in the contract. Proposers should utilize businesses that are physically located in the City of Pompano Beach with a current Business Tax Receipt. Proposers who are unable to meet the recommended voluntary goals should also provide the Local Business Unavailability Form (Exhibit G,) listing firms that were

contacted but not available, and the Good Faith Effort Report (Exhibit H) describing the efforts made to include local business participation in the contract.

5. Contract Award

Upon successful competitive negotiations with the selected Construction Management Firm, an individual Construction Management at Risk contract will be developed for this project including a Guaranteed Maximum Price (GMP) and construction schedule. Construction shall not commence until Notice to Proceed (NTP) is issued by the City.

6. The Project

Work to be accomplished under this contract is related, but not limited to the replacement of a Fishing Pier which construction costs is expected to exceed \$2,000,000.00 subject to Staff's recommendations and City Commission's approval.

7. Insurance

The insurance described herein reflects the insurance requirements deemed necessary for this contract by the City. No contractor or sub-contractor shall commence work under this agreement without the minimal insurance set forth herein, nor without the approval by the City of Pompano Beach Risk Manager. It is not necessary to have this level of insurance in effect at the time of submittal, but certificates indicating that the insurance is currently carried or a letter from the Carrier indicating upgrade ability will speed the review process to determine the most qualified Proposer.

The successful Proposer(s) shall not commence operations until certification or proof of insurance, detailing terms and provisions of coverage, has been received and approved by the City of Pompano Beach Risk Manager.

The following insurance coverage shall be required.

- a. Worker's Compensation Insurance covering all employees and providing benefits as required by Florida Statute, Chapter 440, regardless of the size of the company (number of employees). The Contractor further agrees to be responsible for employment, control and conduct of its employees and for any injury sustained by such employees in the course of their employment.
- b. Liability Insurance
 - 1) Naming the City of Pompano Beach as an additional insured, on General Liability Insurance only, in connection with work being done under this contract.
 - 2) Such Liability insurance shall include the following checked types of insurance and indicated minimum policy limits.

The certification or proof of insurance must contain a provision for notification to the City thirty (30) days in advance of any material change in coverage or cancellation. The successful Proposer shall furnish to the City the certification or proof of insurance required by the provisions set forth above, within ten (10) days after notification of award of contract.

8. GOVERNING LAW

Interested vendors will agree that agreements shall be governed by the laws of the State of Florida, and the venue for any legal action will be Pompano Beach, Florida.

9. CONFLICT OF INTEREST

For purposes of determining any possible conflict of interest, each Qualifier must disclose if any City employee is also an owner, corporate officer, or an employee of his business. If any City employee is also an owner, corporate officer, or an employee, the Qualifier must file a statement with the Broward County Supervisor of Elections pursuant to Florida Statutes 112.313.

10. LOBBYING PROHIBITED

Qualifiers are not to lobby any City officials, officers or personnel related or involved with this Request for Qualifications. All oral and written inquiries are to be directed to the Procurement Contacts contained herein. Any violation of this condition may result in rejection and/or disqualification of the proposal. The City Manager and CIP Manager shall be excluded from this condition.

11. DRUG FREE WORKPLACE

The selected Qualifier with whom an agreement will be negotiated will be required to verify they will operate a "Drug Free Workplace" as outlined in Florida Statute, Section 287.087.

12. PUBLIC ENTITY CRIMES

A person or affiliate who has been placed on the convicted vendor list following a conviction for public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases of real property to public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Florida Statute, Section 287.017, for CATEGORY TWO for a period of 36 months from the date of being placed on the convicted vendor list.

13. TAXES

The CONTRACTOR shall pay all applicable sales, consumer, use and other similar taxes required by law. The CONTRACTOR is responsible for reviewing the pertinent state statutes involving the sales tax and complying with all requirements.

14. HOLD HARMLESS AND INDEMNIFICATION

Proposer covenants and agrees that it will indemnify and hold harmless the City and all of its officers, agents, and employees from any claim, loss, damage, cost, charge or expense arising out of any act, action, neglect or omission by the Proposer, whether direct or indirect, or whether to any person or property to which the City or said parties may be subject, except that neither the Proposer nor any of its subcontractors will be liable under this section for damages arising out of

injury or damage to persons or property directly caused by or resulting from the sole negligence of the City or any of its officers, agents or employees.

15. RETENTION OF RECORDS AND RIGHT TO ACCESS

The selected firm shall maintain during the term of the contract all books of account, receipt invoices, reports and records in accordance with generally accepted accounting practices and standards. The form of all records and reports shall be subject to the approval of the City's Internal Auditor. The selected firm must comply with the Internal Auditor's recommendation for changes, additions, or deletions. The City's Internal Auditor must be permitted during normal business hours to audit and examine the books of account, reports, and records relating to this contract. The selected firm shall maintain and make available such records and files for the duration of the contract and retain them until the expiration of three years after final payment under the contract.

16. COMMUNICATIONS

No negotiations, decisions, or actions shall be initiated or executed by the firm as a result of any discussions with any City employee. Only those communications, which are in writing from the City, may be considered as a duly authorized expression on behalf of the City. In addition, only communications from firms that are signed and in writing will be recognized by the City as duly authorized expressions on behalf of firms.

17. NO DISCRIMINATION

There shall be no discrimination as to race, sex, color, age, religion, or national origin in the operations conducted under any contract with the City.

18. INDEPENDENT CONTRACTOR

The selected firm will conduct business as an independent contractor under the terms of this contract. Personnel services provided by the firm shall be by employees of the firm and subject to supervision by the firm, and not as officers, employees, or agents of the City. Personnel policies, tax responsibilities, social security and health insurance, employee benefits, purchasing policies and other similar administrative procedures applicable to services rendered under this agreement shall be those of the firm.

19. STAFF ASSIGNMENT

The City of Pompano Beach reserves the right to approve or reject, for any reasons, Proposer's staff assigned to this project at any time. Background checks may be required.

20. CONTRACT TERMS

The contract resulting from this RFQ shall include, but not be limited to the following terms:
The contract shall include as a minimum, the entirety of this RFQ document, together with the successful Proposer's proposal. Contract shall be prepared by the City of Pompano Beach City Attorney.

If the City of Pompano Beach defends any claim, demand, cause of action, or lawsuit arising out of any act, action, negligent acts or negligent omissions, or willful misconduct of the contractor, its employees, agents or servants during the performance of the contract, whether directly or indirectly, contractor agrees to reimburse the City of Pompano Beach for all expenses, attorney's fees, and court costs incurred in defending such claim, cause of action or lawsuit.

21. WAIVER

It is agreed that no waiver or modification of the contract resulting from this RFQ, or of any covenant, condition or limitation contained in it shall be valid unless it is in writing and duly executed by the party to be charged with it, and that no evidence of any waiver or modification shall be offered or received in evidence in any proceeding, arbitration, or litigation between the parties arising out of or affecting this contract, or the right or obligations of any party under it, unless such waiver or modification is in writing, duly executed as above. The parties agree that the provisions of this paragraph may not be waived except by a duly executed writing.

22. SURVIVORSHIP RIGHTS

This contract resulting from this RFQ shall be binding on and inure to the benefit of the respective parties and their executors, administrators, heirs, personal representative, successors and assigns.

23. TERMINATION

The contract resulting from this RFQ may be terminated by the City of Pompano Beach without cause upon providing contractor with a least sixty (60) days prior written notice.

Should either party fail to perform any of its obligations under the contract resulting from this RFQ for a period of thirty (30) days after receipt of written notice of such failure, the non-defaulting part will have the right to terminate the contract immediately upon delivery of written notice to the defaulting part of its election to do so. The foregoing rights of termination are in addition to any other rights and remedies that such party may have.

24. MANNER OF PERFORMANCE

Proposer agrees to perform its duties and obligations under the contract resulting from this RFQ in a professional manner and in accordance with all applicable local, federal and state laws, rules and regulations.

Proposer agrees that the services provided under the contract resulting from this RFP shall be provided by employees that are educated, trained and experienced, certified and licensed in all areas encompassed within their designated duties. Proposer agrees to furnish the City of Pompano Beach with all documentation, certification, authorization, license, permit, or registration currently required by applicable laws or rules and regulations. Proposer further certifies that it and its employees are now in and will maintain good standing with such governmental agencies and that it and its employees will keep all license, permits, registration, authorization or certification required by applicable laws or regulations in full force and effect during the term of this contract. Failure of Proposer to comply with this paragraph shall constitute a material breach of contract.

25. ACCEPTANCE PERIOD

Proposals submitted in response to this RFQ must be valid for a period no less than ninety (90) days from the closing date of this solicitation.

26. RFQ CONDITIONS AND PROVISIONS

The completed and signed proposal (together with all required attachments) must be returned to City on or before the time and date stated herein. All Proposers, by submission of a proposal, shall agree to comply with all of the conditions, requirements and instructions of this RFP as stated or implied herein. All proposals and supporting materials submitted will become the property of the City.

Any alteration, erasure, or interlineations by the Proposer in this RFP shall constitute cause for rejection. Exceptions or deviations to this proposal may not be added after the submittal date.

All Proposers are required to provide all information requested in this RFP. Failure to do so may result in disqualification of the proposal.

The City reserves the right to postpone or cancel this RFP, or reject all proposals, if in its sole discretion it deems it to be in the best interest of the City to do so.

The City reserves the right to waive any technical or formal errors or omissions and to reject all proposals, or to award contract for the items herein, in part or whole, if it is determined to be in the best interests of the City to do so.

The City shall not be liable for any costs incurred by the Proposer in the preparation of proposals or for any work performed in connection therein.

27. STANDARD PROVISIONS

a. Governing Law

Any agreement resulting from this RFP shall be governed by the laws of the State of Florida, and the venue for any legal action relating to such agreement will be in Broward County, Florida.

b. Licenses

In order to perform public work, the successful Proposer shall: Be licensed to do business in Florida, if an entity, and hold or obtain such Contractor' and Business Licenses if required by State Statutes or local ordinances.

c. Conflict Of Interest

For purposes of determining any possible conflict of interest, each Proposer must disclose if any Elected Official, Appointed Official, or City Employee is also an owner, corporate officer, or an employee of the firm. If any Elected Official, Appointed Official, or City Employee is an owner, corporate officer, or an employee,

the Proposer must file a statement with the Broward County Supervisor of Elections pursuant to §112.313, Florida Statutes.

d. Drug Free Workplace

The selected firm(s) will be required to verify they will operate a "Drug Free Workplace" as set forth in Florida Statute, 287.087.

e. Public Entity Crimes

A person or affiliate who has been placed on the convicted vendor list following a conviction for public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases of real property to public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Florida Statute, Section 287.017, for CATEGORY TWO for a period of 36 months from the date of being placed on the convicted vendor list.

f. Patent Fees, Royalties, And Licenses

If the selected Proposer requires or desires to use any design, trademark, device, material or process covered by letters of patent or copyright, the selected Proposer and his surety shall indemnify and hold harmless the City from any and all claims for infringement by reason of the use of any such patented design, device, trademark, copyright, material or process in connection with the work agreed to be performed and shall indemnify the City from any cost, expense, royalty or damage which the City may be obligated to pay by reason of any infringement at any time during or after completion of the work.

g. Permits

The selected Proposer shall be responsible for obtaining all permits, licenses, certifications, etc., required by federal, state, county, and municipal laws, regulations, codes, and ordinances for the performance of the work required in these specifications and to conform to the requirements of said legislation.

h. Familiarity With Laws

It is assumed the selected firm(s) will be familiar with all federal, state and local laws, ordinances, rules and regulations that may affect its services pursuant to this RFP. Ignorance on the part of the firm will in no way relieve the firm from responsibility.

i. Withdrawal Of Proposals

A firm may withdraw its proposal without prejudice no later than the advertised deadline for submission of proposals by written communication to the General Services Department, 1190 N.E. 3rd Avenue, Building C, Pompano Beach, Florida 33060.

j. Composition Of Project Team

Firms are required to commit that the principals and personnel named in the proposal will perform the services throughout the contractual term unless otherwise provided for by way of a negotiated contract or written amendment to same executed by both parties. No diversion or substitution of principals or personnel will be allowed unless a written request that sets forth the qualifications and experience of the proposed replacement(s) is submitted to and approved by the City in writing.

k. Invoicing/Payment

All invoices should be sent to City of Pompano Beach, Accounts Payable, P.O. Drawer 1300, Pompano Beach, Florida, 33061. In accordance with Florida Statutes, Chapter 218, payment will be made within 45 days after receipt of a proper invoice.

l. Public Records

1. The City of Pompano Beach is a public agency subject to Chapter 119, Florida Statutes. The Contractor shall comply with Florida's Public Records Law. Specifically, the Contractor shall:
 - a. Keep and maintain public records that ordinarily and necessarily would be required by the City in order to perform the service;
 - b. Provide the public with access to such public records on the same terms and conditions that the City would provide the records and at a cost that does not exceed that provided in chapter 119, Fla. Stat., or as otherwise provided by law;
 - c. Ensure that public records that are exempt or that are confidential and exempt from public record requirements are not disclosed except as authorized by law; and
 - d. Meet all requirements for retaining public records and transfer to the City, at no cost, all public records in possession of the contractor upon termination of the contract and destroy any duplicate public records that are exempt or confidential and exempt. All records stored electronically must be provided to the City in a format that is compatible with the information technology systems of the agency.
2. The failure of Contractor to comply with the provisions set forth in this Article shall constitute a Default and Breach of this Agreement and the City shall enforce the Default in accordance with the provisions set forth herein.

28. QUESTIONS AND COMMUNICATION

clarifications will be without legal effect. Any addendum necessary to answer questions will be posted to the City's website, and it is the Proposer's responsibility to obtain all addenda before submitting a response to the solicitation.

29. ADDENDA

The issuance of a written addendum is the only official method whereby interpretation, clarification, or additional information can be given. If any addenda are issued to this solicitation the City will attempt to notify all known prospective Proposers, however, it shall be the responsibility of each Proposer, prior to submitting their response, to contact the City Purchasing Office at (954) 786 4098 to determine if addenda were issued and to make such addenda a part of their proposal.

SECTION III- SCOPE OF WORK

1. INTENTION

The intent of this "Request for Qualifications" is for the CITY to select a Construction Management Firm (CMAR) capable of providing construction management services necessary to construct the improvements within the CITY as outlined above. Applicants are encouraged to self- perform any of the general services necessary to complete the project. The City shall retain the right to Direct Purchase materials, if desirable. The Construction Management Firm(s) may retain necessary State of Florida licensed design professionals if deemed necessary.

Based on the Guaranteed Maximum Price (GMP), the CITY may or may not proceed if the GMP is not acceptable to the CITY. The CITY reserves the right to discontinue negotiations with the top ranked firm without recourse or liability. Should the CITY choose to discontinue negotiations with the top ranked, the CITY reserves the right to initiate negotiations with the second ranked firm, and so on. The types of services required may include, but shall not be limited to, the following.

2. PRE-CONSTRUCTION PHASE

- A. Review and coordinate the work that the architect, engineer and/or the owner prepared for the project, within the existing site conditions.
- B. Submit to the architect, engineer and owner for consideration, appropriate cost and savings programs (value engineering).
- C. Coordinate competitive bidding and contracting for trade subcontractors.
- D. Calculate and provide a Guaranteed Maximum Price for the project or each phase of the project.
- E. Provide a preliminary construction schedule.

3. CONSTRUCTION PHASE

- A. Provide Performance and Payment Bonds for the full value of the GMP for each phase of the project.
- B. Monitor Local Business and Small Business Enterprises participation (LBE, SBE) for the project or phases of the project.
- C. Apply for, obtain, coordinate and pay for all permits, inspections and tests. Ensure the successful, timely, and economical completion of the project or phases of the project.
- D. Coordinate and insure compliance with all insurance requirements.

- F. Create a schedule of values for the project or phases of the project.
- G. Coordinate Construction Management Services, including but not limited to:

 - 2) Public presentations and Public outreach
 - 2) Maintaining and updating schedules.
 - 3) Overseeing quality assurances.
 - 4) Maintaining and providing copies of all contract documents.
 - 5) Insuring compliance with all safety programs.
 - 6) Coordination of all construction.

4. GENERAL SERVICES

Work to be accomplished under this contract may include the following:

- B. Cost estimating and value engineering.
- C. Development of outline specifications.
- D. Bathymetric surveying.
- E. Landscaping beautification.
- F. MOT (Maintenance of Traffic).
- G. Pedestrian movement (ADA compliance).
- H. Lighting-electrical.
- I. Drainage (Tideflex valves, etc.).
- J. Parking lots (layout, construction, striping, etc.).
- K. Underground utilities (water, wastewater).
- L. Piling design and fabrication.
- M. Dredging and disposal.
- N. Construction of seawalls, piers, docks, boat ramps, boat slips, fender, and berthing pile systems and configuration, safety railings, site amenities.
- O. Construction details.
- P. Construction specifications.
- Q. Technical specifications.

5. COMPOSITION OF PROJECT TEAM

Qualifier will be required to commit that the personnel and/or principals named in the proposal shall remain assigned to the "project" throughout the period of the contract unless provided for otherwise in a negotiated contract. No diversion or substitution of personnel or principals will be allowed without submission of a written request with the qualifications and experience of the proposed replacement. The approval of the CITY will be required for any such diversion or substitution.

6. LICENSE

Firms must have previous municipal experience and must be licensed to practice General Contracting and Professional Services in the State of Florida in accordance with all applicable State, County and City regulations and licenses.

SECTION IV - SELECTION/EVALUATION PROCESS

1. Interested Respondents shall submit their qualifications and any other information required herein to the City of Pompano Beach's Purchasing Department's office on or before the date and the time specified.
2. Each partner of joint ventures must individually meet the conditions of the General Contractor's Evaluation. Contractor's License may not have been suspended, put on probation or revoked at any time in the last five (5) years.
3. Limited Liability Corporations (LLC) will be required to comply with a Guaranty of Obligations.
4. General Contractor shall provide a complete financial statement indicating organization's financial condition (sealed envelopes are acceptable). Financial statements provided by general contractors shall not be older than six (6) months prior to the date of filing this Prequalification Application. The financial statements are to be reviewed and submitted with any accompanying notes and supplemental information. The City of Pompano Beach reserve the right to reject financial statements in which the financial condition shown is of a date six (6) months or more prior to the date of filing. The City is a public agency subject to Chapter 119, Florida's Public Records Law and is required to provide the public with access to such public records unless the records are exempt or confidential as authorized by law.
5. A certificate by a Certified Public Accountant (CPA) is required. The CPA may submit a certificate in his/her own words, including such qualifications as may be necessary in view of the scope of this assignment, provided that such qualifications shall not be so extensive as to nullify the value of the statement or its usefulness to the City of Pompano Beach. Certificate shall be signed and shall indicate license/certificate number.
6. Bearing in mind that working capital is an important factor in determining the prequalification of the general contractor, the accountant will perform a valuable service for their client and at the same time assist the City, if they will furnish, by supplemental schedules or as part of their certificate, any information not specifically called for by the statement which in their opinion might be taken into consideration. In the event that the general contractor's job income and expenditures are accounted on a completed contract basis and the balance sheet includes an item reflecting the excess of costs to date over billings to date, or vice versa, the elements of "Accumulated Costs" and "Billings to Date" must be shown in support of the balance sheet item.
7. A Selection/Evaluation Committee will be appointed and will be responsible for selecting the most qualified firm. The Selection/Evaluation Committee will then present their findings to the City Commission and upon their approval, negotiate contract with the most qualified firm.
8. The Committee will rank responses based upon the following criteria:

The Committee has the option to use the above criteria for the initial ranking to short-list Proposers and to use an ordinal ranking system to score short-listed Proposers following presentations (if deemed necessary) with a score of "1" assigned to the short-listed Proposer deemed most qualified by the Committee.

Each firm should submit documentation that evidences the firm's capability to provide the services required for the Committee's review for short listing purposes. After an initial review of the Proposals, the City may invite Proposers for an interview to discuss the proposal and meet firm representatives, particularly key personnel who would be assigned to the project. Should interviews be deemed necessary, it is understood that the City shall incur no costs as a result of this interview, nor bear any obligation in further consideration of the submittal. The City may request individual presentations if the review Committee deems it appropriate for ranking and scoring purposes.

When more than three responses are received, the committee shall furnish the City Commission (for their approval) a listing, in ranked order, of no fewer than three firms deemed to be the most highly qualified to perform the service. If three or less firms respond to the RFQ, the list will contain the ranking of all responses.

The City Commission has the authority to (including, but not limited to); approve the recommendation; reject the recommendation and direct staff to re-advertise the solicitation; or, review the responses themselves and/or request oral presentations and determine a ranking order that may be the same or different from what was originally presented to the City Commission.

 - 3. State whether the organization is national, regional or local.

4. State the location of the office from which the work is to be performed.
 5. Describe the organization of the proposed project team, detailing the level of involvement, field of expertise and estimated hours for each member of the team.
- E. Provide a list and description of similar municipal or other projects satisfactorily performed within the past five (5) years that have been completed under a "Construction Management at Risk Services" agreement. For each project listed, include the name and telephone number of a representative for whom the project was undertaken who can verify satisfactory performance. Describe experiences in conducting similar projects for each of the staff assigned to the project, as well as their relevant educational background.
 - F. Provide information on any litigation (decided, settled or pending) the firm has been involved in within the last five (5) years.
 - G. Describe what municipal staff support is anticipated for this type of project.
 - H. Describe the firm's approach to performing the work. This should include the following points: overall plan for this project outlining major tasks and responsibilities, project time schedule and staff assigned.
 - I. Provide reviewed or audited financial statements for your most recent past three (3) complete fiscal years, accompanied by a review report by an independent Certified Public Accountant. Compiled or internally prepared financial statements will not be accepted.
 - J. Insurance certificate and any other forms the Qualifier feels are pertinent.

The Submittal Package shall include a completed sample insurance certificate listing the insurance company's name(s) for both Professional and General Liability Insurance and the dollar amounts of the coverage.

All copies will be on 8 ½" x 11" plain white paper, typed, and signed by an authorized representative who is able to contractually bind the Proposer. Whiting-Turner is pleased to provide this preconstruction services proposal for Pompano Beach's landmark Fishing Pier project. During preconstruction, Whiting-Turner will perform various services to assist Pompano Beach in the project development. Our scope of work will include participating in design team meetings, assisting with development of the project schedule, securing an initial opinion of probable cost based on the most current information available, conducting constructability reviews and cost updates as the design progresses, and culminate in the submission of a Guaranteed Maximum Price (GMP) as the design approaches completion. The scope of our preconstruction services is more completely discussed as follows:

Task I**PRECONSTRUCTION PROGRESS MEETINGS**

The scope includes regularly scheduled team progress meetings attended by Whiting-Turner, as well as design professionals, Pompano Beach representatives and others. Whiting-Turner will provide agendas and produce meeting notes from each meeting documenting the issues of the project, assigning responsibility for issue resolution and tracking the timelines for issue resolution.

TASK I - TOTAL FEE \$7,400.00

Task II**SCHEDULING**

Based on the best available information, Whiting-Turner will develop a master Pre-Construction & Construction Phase bar chart schedule incorporating design development, permitting, plan review, guaranteed maximum price preparation, submittal review and approval, long lead item identification and procurement. Design professionals will identify required permits. The Pre-Construction schedule will include summary activities for construction of the key project elements. This activity includes consultation with an outside scheduling consultant. The schedule will be presented to the Owner for review and comment as necessary until established, and shall be updated monthly thereafter to track preconstruction progress and for inclusion in the GMP.

TASK II - TOTAL FEE \$8,500.00

Task III**COST ESTIMATING****A. INITIAL OPINION OF PROBABLE COST:**

This budget is based on the best available current information, and it is intended to provide Pompano Beach with initial input on the conceptual cost of the work. This budget will also provide conceptual feedback related to the various options or alternates that Pompano Beach and the design team may be considering for the fishing pier, in order to assist with the decision making process. This budget may rely both upon our in-house takeoff utilizing historical unit prices from

similar projects, as well as subcontractor and vendor feedback. Work entails review of the plans provided, quantity surveys, review with the Owner and design team to discuss final design intent, details not yet addressed, and potential construction scope gaps which may not yet be addressed at the current design level.

TASK III.A - TOTAL FEE \$8,500

B. CONSTRUCTABILITY REVIEW

The scope includes continual review of the plan details as periodically provided by the Design Team. The review will identify design criteria which may present considerable constructability challenges, and also will assist the Design Team in any plan modifications and re-design.

TASK III.B - TOTAL FEE \$14,400

C. GUARANTEED MAXIMUM PRICE (GMP)

The scope consists of Whiting-Turner preparing the guaranteed maximum price and the final construction budget based on substantially complete construction documents provided by the design team. The GMP will include a detailed line item budget for all major items of work to be performed. Those project scope of work items that the plans are not yet developed for, may be included in the GMP as Allowance items, or may be added to the contract at a future date by change order. Whiting-Turner's general conditions shall be detailed as well as the construction phase fee. The GMP shall also include the Contingency. The aforementioned information shall be presented to the Owner along with all supporting documentation for review and approval. This agreed upon document shall become the basis of the construction services phase of the project and shall conclude the pre-construction services phase of the project.

TASK III.C - TOTAL FEE \$41,100

Task IV
CONTINGENCY

This contingency will allow for input from various third party consultants, such as environmental, surveying, or geotechnical consultants. Invoices for these services, when utilized, will be provided as back-up. If some or all of this contingency is uncommitted at the completion of preconstruction activities, then the balance will be returned to the Owner.


