ADDENDUM #1, BID E-32-14

Football Uniforms and Equipment

To Whom It May Concern,

Please review the following questions/comments submitted by potential bidders, and answers from the City.

Q1: For the game uniforms, Strong Arm Athletics is not a uniform manufacturer. Can you please tell me who the manufacturer is?

Response: Replace all references to "Strong Arm Athletics or equal" with "GTM Sportswear Ultrafuse or approved equal."

Q2: On the game jerseys, do you want them sublimated or tackle twill?

Response: Game Jerseys will be fully sublimated, so delete any language requesting sewn-on team names and numbers.

Q3: For the game pants, what is the model? Is it a solid pant or a pant with inserts?

Response: We require only solid pants with sewn-in rump, hip, thigh, and knee pads.

Q4: Do the Eagles get one set of pants or two?

Response: Both teams get one set each of game and practice pants.

Q5: On the helmets, I have two options that match up with the Riddell Revolution Attack youth helmet. Am I permitted to bid 2 helmets or only one?

Response: Please bid on one type of helmet.

Q6: On the jaw pads, did you want foam or vinyl covered?

Response: Please bid on vinyl covered jaw pads.

Q7: What make and model chin strap are you looking for? Youth 4-point high and low hook-up as per page 9. Do you want the foam cup or the flannel lined cup?

Response: We only require that the soft cup chin strap be compatible with the Riddell Revolution Attack youth helmet.

Q8: For the field pylons, do you want the weighted pylons? They are typically sold as a set of 4. Did you want 12 sets or only 3?

Response: On page 23 of the bid document, we asked that the 12 each be priced as "3 sets" of four. Please provide pricing for weighted pylons.

Q9: Do you have a make and model on the yard markers? If not, what type do you want? Folding, block, stackable?

Response: Please offer pricing on folding yard markers. We have no make or model.

Q10: Down markers – do you want the dial a down type or a flip style marker? Did you want just the down marker or do you need the chain set as well?

Response: Please provide pricing on the chain and flip style markers as a set.

Q11: What color shoulder pad laces are you looking for, black or white?

Response: Please provide pricing for black laces.

Q12: Can you provide an image of the uniform on this year's bid. I see that the spec was changed to include Sublimation.


Response: See Attachments 1 and 2 for respective samples of the Eagles' and Cowboys' uniforms.
