I acknowledge that I have received, read and understand the City of Pompano Beach Zoning Code Section 155.4303.S,
pertaining to Home Based Business. Further, I agree that the business listed above shall be conducted in compliance
with Zoning Code Section 155.4303.S, and as well as all city code requirements.

Zoning Code Section 155.4303.S

"A home based business is allowed as an accessory use to any principal dwelling unit, subject to the following
standards:

- a. The home based business shall be located within the dwelling or an associated accessory building (but not an
accessory dwelling unit), and involve an area that does not exceed 25 percent of the floor area of the principal
structure, or 500 square feet, whichever is less.
b. The operator of the home based business shall be a full-time resident of the principal dwelling.
c. No person other than full-time residents of the principal dwelling may be employed in connection with the home
based business.
d. The home based business shall cause no change in the external appearance of the existing dwelling and structures
on the property.
e. There shall be no outdoor display or storage of goods, equipment, or services associated with the home based
business.
f. There shall be no other exterior evidence to indicate that the premises are being used for any purpose other than for
a dwelling use.
g. There shall be no direct, on-premise retail sales to customers.
h. There shall be sufficient off-street parking for patrons of the home based business, with the number of off-street
parking spaces required for the home based business provided and maintained in addition to the space or spaces
required for the dwelling itself.
i. The home based business shall not involve significantly greater volumes or frequencies of deliveries or shipments,
vehicular traffic, or pedestrian traffic than normally expected in a residential area.
j. The home based business shall not generate noise, vibration, odor, glare, fumes, or electrical or communications
interference (including visual or audible interference with radio or television reception) that can be detected by the
normal senses off the premises."
