Old Town Pompano - 41 NE 1st Street, Pompano Beach 33060

(NE Corner of Atlantic Boulevard and Dixie Road, across the street from Pompano Beach's City Hall)

**Cost:**

The standard rent for vending at the market is \$30 per Saturday. This fee is for a 10' x 10' space. All vendors are required to have a tent at this event.

**NEW Early Bird Special Rates for 2019-2020:**

- \$575 for all 26 dates per 10'x 10' space (Discounted rate for entire season—*save \$205!*)
- Pay for 3 Saturday's upfront and receive 1 Saturday FREE (4 *consecutive* Saturday's for \$90 — *save \$30!*)
- Vendors must commit to a minimum of four *consecutive* Saturday's, unless approved by the Market Manager for Vendors only invited and attending Special Events.
- Before joining the Green Market, vendors must pay their vendor fee.
- Vendors who fail to show up at the Green Market without giving the Market Manager 24 hours notice will forfeit that week's vendor payment (non-refundable or transferable). Should you want to re-enter the market the following week, you must contact the Market Manager directly to get approval.
- There are NO REFUNDS under any circumstances. This is a RAIN or SHINE Event. In the case of inclement weather, only the POMPANO BEACH CRA can give authorization to close the market.

## Green Market Agreement & Rules

### Eligibility Guidelines

- ◆ I agree to sell/promote only those products approved by the Green Market Manager.
- ◆ The Green Market is intended to promote Fresh Produce/Fruits and Organic & Holistic Products, Handmade goods.
- ◆ Special Events may include additional crafters/artists, vintage/retro and other genres of vendors that apply.

### Licenses, Health Codes, and Insurance

- ◆ Obtaining the proper licenses or permits, and obeying all codes is the sole responsibility of the vendor, including any regulations of the Florida Department of Agriculture or other regulatory agencies.
- ◆ I acknowledge full responsibility for all of my activities at the Market and for those employed or assisting in my sponsor's space and I agree to defend, hold harmless and indemnify the City of Pompano Beach, Pompano Beach CRA and Pompano Beach Historical Society, its agents, successors or assigns from any liability, cost, damage or expense, which arise from my employee's or agent's involvement and operation in the Market or use of the sponsor's space.
- ◆ ***Please sign Hold Harmless Agreement and return with your application.***
- ◆ I understand that the City of Pompano Beach and the Green Market Pompano Beach, its agent's, successor's or assigns, do not carry insurance policies to cover individual vendors/sponsors and their products or rental space and that I am required to provide my own coverage.

### General Guidelines

- ◆ Electric will be available as it exists currently within the event site, but it is limited and not guaranteed. This power is intended for only lights and low power source accessories. Any cooking equipment, blenders, etc. will create a power outage for the entire event site. Small quiet generators are permitted for these cases but must be approved by the Market Manager. No further alterations or upgrades will be provided by the City of Pompano Beach or the Market. Vendor must provide own extension cords and power strips.
- ◆ All sampling and business transactions must take place within your booth space.
- ◆ Two no calls-no shows will result in being removed from the market with NO REFUND.
- ◆ There are no exclusive vendors at the Green Market; however, we will not saturate the market with same use vendors. The decision on how many vendors may sell the same type of product rests solely with the Green Market Manager.
- ◆ Tents must be properly secured with weights. It is the responsibility of the vendor to properly secure tents with weights. Wind can take down a tent and cause serious damage to you and to others. Any vendor that does not bring weights will not be allowed to set up and no refund will be given.
- ◆ Company name identification is required on each booth (Banners are Required) and tables must have tablecloths on them.
- ◆ Rules are subject to change without advance notice.

### Set Up/Breakdown/Clean-Up

- ◆ Set-up begins at 6:30am and every vendor must be completely set up 8pm, car/van removed, and booth fully operational and displayed. Event starts at 8:30am.
- ◆ Clean-up – Every item you bring must be removed by you. Please stay at your booth until your employees have completed all clean up. If City employees must clean or dispose of your garbage, a \$50 fee will be charged before entering the next market. Do not break down before 1:30pm.

*NOTE: This documents does not cover every conceivable rule, regulation or guideline put forth by Green Market Pompano Beach, the City of Pompano Beach or the State of Florida. While the Green Market will make every effort to keep vendors informed of such, in the final analysis it is the responsibility of vendors to aware of and abide by all rules, regulations and guidelines.
