The 26th annual Nautical Flea Market will be held at the Community Park (on Federal Hwy between NE 6th & 10th Streets) in Pompano Beach. Vendor spaces measure approximately 10' x 20' for merchandise & 15' x 25' for boats & trailers. The vendor must sell marine related items. The cities reserve the right to reject those vendors that do not meet these conditions. All merchandise, trailers, vehicles, etc. must fit within your allotted space. If for any reason your "stuff" does not fit within your space you will be required to purchase additional spaces. Due to the layout of the park & its curved walkways, spaces may not be "square" and may be adjacent to another vendor. If you have any special needs please notify us in advance via email (info@nauticalfleamarket.com) & we will try to accommodate you.

Vendors must complete the application and submit all fees prior to be assigned a space. Payment must be cash, check or money order; we do not accept credit cards. To qualify for the early bird discount your payment must be received or postmarked no later than 11/30/15. Florida Sales tax (6%) is applicable on all vendor spaces. Vendors will receive 2 passes per space purchased; additional passes are available for \$5 each.

Applicants will be notified via email in **late December** with their location number, load in time & other move-in information.

The Cities of Pompano Beach & Lighthouse Point reserve the right to restrict the type and number of vendors; and to select vendors who best meet the needs of the event. Vendor placement is at the event staff's discretion. The event is held rain or shine; no refunds will be given. Firearms, stun-guns & other weapons are not prohibited. The sale of any spear-fishing weapons to minors is prohibited. Only City approved food vendors may sell any type of food or drinks; including alcohol, beer & bottled water.

*Note that you may drive in with your vehicle to set up but all vehicles must either be removed from the park by Friday, January 22nd by **4 pm** or remain until the close of the show on Sunday, January 24th at 3 pm. You can walk to your booth any time on Friday from 7 am to 5 pm or from 6 am on Saturday and Sunday but no vehicles are allowed after 4 pm on Friday as the Fire Dept locks the gates.*

Since the event is located in a park the spaces are often not “square” or may be adjacent to another vendor. We must know this in advance so that we can put you in a space that can accommodate your needs.

Load In is scheduled by Zone:

Morning (7 am to Noon) - Zone’s “B” white, “C” green, Zone “A” spaces #1-20 only

Afternoon (noon to 4 pm) - Zones “A” blue, “D” yellow

If you are scheduled for afternoon load in you will not be permitted to drive in until 12 Noon as we need your space for the early vendors to drive to their booth. We appreciate your understanding & cooperation with this.

You must provide your own booth preparations. Bring your own tables, counters, chairs, tents, tarps, shade and/or weather protection, etc. No water or electric service is provided. Due to fire regulations **generators are not permitted** (inverters are ok). Police security will be on site Friday & Saturday nights. Only City approved food vendors may sell any type of food or drinks (including alcohol & bottled water).
