

Property Tax Exemption Filing Dates Announced For JANUARY 2017

The Broward County Property Appraiser's Office hosts a series of community outreach events each month throughout Broward County. Deputy Appraisers will be available to assist with Homestead, Senior and other property tax exemption applications, as well as answer questions on property taxes. We are also accepting applications for Portability. The outreach program is designed to provide convenient and accessible service to the residents of Broward County. All outreach events listed below are open to the public.

Documents required to file a Homestead Exemption include:

- A current Florida driver's license or Florida identification card, and
- A current voter registration card or declaration of domicile
- Non-US citizens must also provide proof of permanent residency.

The deadline to file for all 2017 exemptions is March 1, 2017 with a late filing deadline of September 18, 2017.

Qualified residents 65 years of age or older as of January 1, 2017 may also apply for the additional Senior Exemption. Eligible seniors must have a total household adjusted gross income not to exceed \$28,482. Documents required for the Senior Exemption include a 2016 income tax return or, if one does not file income taxes, a copy of the 2016 Social Security 1099 Form.
