

SECTION 1. The First Amendment to the Consulting/Professional Services Contract between the Pompano Beach Community Redevelopment Agency and Design Kollaborative Architects Planners, Inc., a corporation authorized to do business in the State of Florida (the “Original Agreement”), extending the term of the Original Agreement until May 23, 2018, a copy of which First Amendment is attached hereto and incorporated by reference as if set forth in full, is hereby approved.

SECTION 2. The proper officials are hereby authorized to execute the First Amendment.

SECTION 3. This Resolution shall become effective upon passage.

THIS IS A FIRST AMENDMENT TO THE CONSULTING/PROFESSIONAL SERVICES CONTRACT dated May 23rd, 2013 between:

POMPANO BEACH COMMUNITY REDEVELOPMENT AGENCY, a public body corporate and politic, whose address is 100 West Atlantic Boulevard, Pompano Beach, Florida, (the "CRA"),

and

DESIGN KOLLABORATIVE ARCHITECTS PLANNERS, INC., a corporation, authorized to do business in the State of Florida, whose principal address is 24 NE 24th Avenue, Pompano Beach, Florida 33062 (the "Consultant").

WHEREAS, the CRA and Contractor entered into a Consulting/Professional Services Contract (the "Original Agreement"), approved by Resolution No. 2013-56; and

WHEREAS, Article 2 of the Original Agreement provides for an original one year term with four additional twelve month renewal periods; and

WHEREAS, the CRA desires to renew the Original Agreement for the final twelve month renewal period ending May 23, 2018; and

WHEREAS, the CRA desires that the Consultant provide architecture and design services for various CRA projects during the term.

NOW, THEREFORE, the parties agree as follows:

1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.
2. Except as amended by this First Amendment, the Original Agreement shall remain in full force.

3. The CRA and Consultant agree to extend the term of the Original Agreement for the final twelve month renewal period ending on May 23, 2018.
